### **SUMMARY REPORT OF COURT 22<sup>nd</sup> NOVEMBER 2019**

The University Court met today, 22 November 2019, and welcomed Dr Walter Roettger, Interim Provost at Glasgow Caledonian New York College who discussed with the Court the College's current status and the implementation of its plans now that all the key regulatory requirements had been fulfilled and essential permissions were in place.

Yesterday evening the Court, together with students and members of staff, heard from Ben Page, Chief Executive of IPSOS Mori, who gave an engaging and topical talk on "Britain, the election and after...".

## 1. Principal & Vice Chancellor & Executive Board Report

The DVC (Strategy) presented the report which provided a summary of items arising since the previous Court meeting. Among topics he highlighted were the shortlisting in the Scottish Public Services Awards of the University's student and staff led campaign against gender-based violence; the national recognition of the University's Promoting Excellence in Employability and Transversal Skills team through a prestigious Collaborative Award for Teaching Excellence from AdvanceHE; the University's rise by five places in The Times and Sunday Times Good University Guide 2020; and recognition of the commitment shown by the University to social mobility in the naming of Professor Pamela Gilles as the Social Mobility Champion for the UK at the UK Social Mobility Awards 2019.

# 2. Student President's Report

The Student President, Eilidh Fulton, reported on the Students' Association's current key topics in her Court Report which confirmed the election timetable for the Full Time Officer Elections in 2020.

### 3. Chief Operating Officer's Report

The Court noted the report which referred to topics relating to finance, staffing and the estate and confirmed that the full results of the staff engagement survey will be available in January.

## 4. University Secretary's Report

The Court noted the report and in particular the date of the University's first stakeholder meeting in Glasgow to which students, staff and external stakeholders are invited on Wednesday 19<sup>th</sup> February 2020 and the rescheduled date for the London Stakeholder Event of Thursday 12<sup>th</sup> March 2020.

Court also noted the final Self-Evaluation Report relating to the 2018-19 Outcome Agreement which was submitted to the Scottish Funding Council by the 31<sup>st</sup> October 2019 deadline.

## 10. GCU Strategy Development - Update

The Court held a highly productive Strategy Day on 17<sup>th</sup> October 2019 and noted the update report which set out the timetable for the next steps and the current strands of work for the development of Strategy 2030.

## 11. Final ELIR 4 Reflective Analysis

The Court noted the final version of the Reflective Analysis which will be submitted to the Quality Assurance Agency on 28<sup>th</sup> November 2019.
