- . By the Chair that SFC Outcome Agreement guidance had been received and work was underway on the preparation of the final draft for submission at the end of April. The Public Spending Review would determine funding, and this would be dependent on the outcome of the forthcoming general election. Overall, it was considered that a cash flat, one-year settlement, would be a realistic expectation.
- ii Further information on the review of the Widening Access and Retention Fund was awaited from the SFC, however as the University was a major beneficiary of the fund, changes were anticipated. It was hoped that as there was increased requirement within the sector for widening access provision, that overall funding would be increased in order to support the maintenance of existing provision. However, given the wider financial position, that seemed unlikely.
- iii. The Chair expressed appreciation for the collaborative approach taken by staff and students in response to the recent industrial action and the ongoing action short of a strike.
- iv. Colleagues were invited to visit the Points of Pride exhibition that demonstrated ways in which staff had embodied GCU Values.
- v. The results of the Staff Pulse Survey undertaken in the autumn had been received.

 They were being analysed and would be shared with staff in the new year.

Mitigating Circumstances Policy Update

19.062 Received Proposed amendments to the University's Mitigating Circumstances Policy (Doc APPC19/17/01).

19.063 Reported

By the Head of Academic Quality that amendments to the Mitigating Circumstances Policy had been considered and agreed by the Academic Policy and Practice Committee (APPC). These amendments included an element of additional, discretionary consideration to Assessment Boards; a refresh of School Mitigating Circumstances Boards; reframing of retrospective mitigating circumstance and a review of the Personal Tutor Statement template. Additionally, a root and branch review of the approach to mitigating circumstances, in order to reflect fundamental changes in the sector, was underway.

19.064 Discussed

- i. The Student President raised concern the proposed, revised changes had not been considered by the Student Action Group for Engagement (SAGE). In particular a number of concerns about the potential detrimental impact of the proposed amendments to retrospective mitigating circumstances had been raised within the Students' Association following APPC consideration of the matter. Student Senators requested additional time for consultation with the Students' Association on the proposed changes to retrospective mitigating circumstances, but were supportive of the other proposed changes to the policy whilst the root and branch review was underway.
- ii. It was further requested by Student Senators that electronic submission be included in a refreshed Mitigating Circumstances Policy.
- iii. The Head of Academic Quality stressed that even with the proposed changes to retrospective mitigating circumstances, Boards would always act with compassion and in the best interest of students, and that changes were aimed at making the process easier for students. Additionally, the University wide mitigating circumstances board would continue to consider more complex cases, and that no student in extremis would be disadvantaged. Whilst noting these reassurances, the Student Senators remained concern that the changes to retrospective mitigating circumstances could severely disadvantage students.
- iv. Whilst some of the proposed changes were welcomed by Senate, the decision to make changes to the policy in advance of the conclusion of the wider root and branch review was queried.

- b) To request that a revised policy be submitted to the next meeting of Senate, if possible, and that it be submitted to SAGE prior to APPC and Senate.
- c) Consideration be given to including electronic submission to the refreshed policy.
