CHAIR'S REPORT

12.008 Reported By the Chair, the following items for the attention of LTSC:

- That the setting of fees for RPL claims will be submitted to APC for approval;
- Blended Learning Review: a thematic audit of Blended Learning within Schools will be undertaken. A programme of thematic audit is currently being drawn up, with 2 audits scheduled per year.
- Staff are encouraged to engage with internal audit and programme approval/re-approval activity to widen the pool of internal panel members.
- An away day was held on 23rd August to review current University processes and procedures with a view to updating and improving these. A number of working groups will be set up.

GCU LONDON: QUALITY ENHANCEMENT VISIT

12.011 Considered The report on the Quality Enhancement visit to GCU London held on 1

March 2012 (Doc LTSC12/02/1).

12.012 Reported That the purpose of the visit to the GCU London campus had been

twofold:

 as part of the ELISR for the Department of Law, Economics, Accountancy and Risk (LEAR)

• a review of the student experience

The Panel reviewed the physical resources and spoke to staff and students. The effort and goodwill of Glasgow-based staff is noted in the report, as are the issues raised by staff and students which require to be addressed.

12.013 Discussed

It was noted that there was no student representative on the review panel. It is a requirement that student representatives sit on ELISR panels, and whilst the visit to GCU London was not a formal internal subject review, the exclusion had not been a deliberate decision.

The differences between the original version of the GCU London report and the current version were queried. The original version did not set the review in context and did not contain an action plan. However, the key issues highlighted in both reports remain the same. The current version of the report has now been approved by the Chair of the LEAR ELISR panel as an accurate record.

12.014 Discussed

The GCU Action Plan in Response to the Quality Enhancement Visit Report.

- Academic Development Tutor Support
 The Action Plan does not address the impact of GCU London on ADTs based in Glasgow. It was noted that additional London-based staff will be appointed.
- ii. Support for London-based Staff London-based staff should be included in AcceleRATE. New staff will spend around 20% of their time in Glasgow and will be provided with relevant training and support.

iii. Student Issues

- Female prayer room: Local facilities have been identified close to the GCU London campus and the details communicated to students
- Lack of communication to students has been identified as a key problem
- Library: Work has commenced on improving the library space and its progress will be kept under review. Douglas Little to provide an update on progress of work (Action: MM)
- Reading lists: Glasgow-based library staff have reviewed the procedures with staff in the GCU London library.
 There had been an issue with obtaining reading lists from Module Leaders, however improved liaison between library and academic staff should improve this.
 Timetabling is key to resolving this issue: provision of reading lists requires to be more efficient and timeous
- English language support: students were unaware of the support available, both centrally by the University and by GSBS. This issue requires to be monitored by the Liaison Group
- Careers Service: A McCulloch has attended the GCU London campus to identify students' needs, which differ from those of Glasgow-based students. Discussions

regarding shared resources are currently taking place with other London campuses. A proposal will be submitted to the Executive Board at the end of October.

A follow-up on the Action Plan will be undertaken before Christmas and the findings reported to LTSC. A Liaison Group will be established shortly and will require the inclusion of a wide range of both administrative and academic staff. The group will report to LTSC.
