SUMMARY REPORT OF COURT 17th February 2022

The University Court met virtually on Thursday 17th February 2022 and congratulated Professor Alastair Robertson, PVC Learning and Teaching, and Fiona Campbell, Vice-Principal People and Student Wellbeing, on their now substantive appointments. The Court further extended congratulations to Professor Cam Donaldson and Professor Sebastien Chastin for their exceptional placing in key world academic rating reviews.

Court noted that the annual virtual stakeholder event for staff, students and external stakeholders would be taking place at 4pm on the same day as Court on the topic of 'Our sustainable future'.

1. Recruitment of the Principal's successor

The Court approved the framework for the recruitment as well as the final membership of the Search Committee. The Search Committee is based on the Court Governance and Nominations Committee membership with the addition of a TU nominated governor and the professional and support staff elected governor. The Committee is not large, being designed for agility rather than comprehensive representation. The Committee's work will be undertaken, however, against the background of feedback from thorough consultation activity led by Saxton Bampfylde, the executive search company appointed to support the Court in this important task.
