Following a review of the NSS which commenced in 2014 the new National Student Survey (NSS) questionnaire will be introduced in January 2017. This is the first time that substantial changes have been made to the NSS since its inception in 2005 (GCU has participated in the NSS since 2008).

Changes to the 2017 survey include:

- new sections on learning opportunities, learning community and student voice,
- nine new questions on student engagement,
- updated questions on assessment and feedback and learning resources,
- removal and transfer of personal development questions to the optional question banks,
- removal of two duplicative questions to ensure the survey remains short.
- The funding bodies intend to review the impact of the new survey on providers and students. The outcome from this work will inform whether any revisions to the survey are required for NSS 2018, including if any additional support and guidance is required for students or HE providers.
- That any feedback on the new NSS should be submitted to Mrs Roden, Deputy Director Strategy and Planning.
- That the survey will be communicated to students when questions have been finalised.
