18.094	Reported	i.	The DVC (Academic) informed Senate that whilst the upgrade to GCULearn had been scheduled for over the Christmas break as that was a period of traditionally low usage, the upgrade over ran slightly and as a result of this there was concern from the student body about the impact the downtime would have on forthcoming assessments. In close collaboration with the Students' Association, Schools and professional support departments, a number of mitigating actions had been put in place to ensure that students were not academically disadvantaged by the downtime.
		ii.	It was acknowledged that the communication to students and staff prior to the downtime was sub-optimal, and that lessons would be learned for this for future upgrades
18.095	Discussed		It was raised that one of the mitigating actions in place was the opportunity for early retrieval of failed assessments to allow students to graduate in July. Senate was informed that this was an issue that had already been under exploration, and its introduction on this occasion on an exceptional basis would be reviewed and discussed with staff and students to ascertain whether this was something that should be introduced as part of the regular assessment calendar, and report on this would be submitted to Senate

#### Assessment Regulations Working Group - Assessment Procedures Staff Handbook

18.100	Considered	The Assessment Procedures Staff Handbook (Doc S18/44/1)
18.101	Reported	The Assessment Procedures Staff Handbook had been reviewed following consultation with staff and students. The revised document signposted staff to all assessment regulations and policies and the associated staff responsibilities at all stages of the assessment process.
18.102	Discussed i.	It was raised that the Handbook stated that student work should be retained for one calendar year from the date of the Assessment Board, and it was queried whether this was sufficient, especially in light of the need to review student work in cases of academic misconduct. It was further raised that student work previously had to be retained for one year after completion of studies. It was therefore agreed that further consideration of this be given.

18.105 Reported By the Chair of the Assessment Regulations Working Group that work had been undertaken to consider whether there were any barriers to the introduction of banded grading to replace the current method of numerical grading used within the University. Following this initial work, further detailed exploration of the matter by a task and finish group had been approved by Academic Policy and Practice Committee and Senate's views on the proposals were sought.

- 18.105 Discussed

   It was noted that banded marking was already being used by a large number of HEIs, and whilst there were some challenges in specific subject areas, overall it was considered a positive approach to providing results and feedback to students, as well as providing more clarity in the marking process.
  - ii. The need for detailed analysis and evidence to support a move to banded grading was stressed and it was requested that sector benchmarking be undertaken.
  - The Student President advised that there were mixed views within the student body, and requested that draft proposals be submitted to SAGE for consideration.
- 18.106 Resolved To endorse the establishment of the task and finish group, and that a detailed report be submitted to SAGE and Senate in June 2019 if possible.

### **UK Degree Classifications**

#### 18.107 Considered

A report outlining work that had been undertaken to look at UK Degree Classifications by the UK Standing Committee for Quality Assessment (UKSCQA).

#### 18.108 Reported

- i. By the DVC (Academic) that analysis had shown that there had been an upward trajectory in the awarding of upper degree classifications (first class and 2:1) across the UK. Whilst there were potentially a number of factors involved in this shift, and variations in the increase between different institutions, it was considered that the sector should address the matter in order to protect public confidence in the honours degree classification system.
- ii. Within the University there had also been an increase in the awarding of first class and 2:1 degrees, although not to the same extent as the overall sector increase. Degree classification calculations differed from programme to programme, and two core schemes and nine additional schemes were currently used.
- iii The matter had been discussed at APPC where it had been noted that the University was contributing to discussion of this matter in the sector. APPC had approved the establishment of a task and finish group and an outline of activity in order to gain a greater understanding of the position within the University.

#### 18.109 Discussed

- The upholding of academic standards was considered to be essential, however it could appear as if students and HEIs were being punished for being successful. It could also be that the marketisation of higher education in certain parts of the sector had resulted in an increased focus on results. Furthermore, as many graduate recruiters required a 2:1 minimum, this too may have had an impact, in terms of both students and HEIs knowing employers' expectations.
- ii The UKSCQA work had also stimulated debate around the use of GPA instead of degree classification.

### 18.110 Resolved

Senate welcomed and endorsed the work to be undertaken by the task and finish group, and requested that consideration of GPA be included in the programme of work and that an update report be submitted to the next meeting of Senate.

#### 18.113 Reported

By the PVC Research that following guidance issued in January 2019, the Draft Code of Practice for REF2021 had been prepared. The Code was currently the subject of consultation that closed that day and Senate's views were requested.

ii A key element of the Code was inclusiveness, however it was recognised that not all staff would be included. Initially the identification of staff with "significant responsibility for research" would be made by Schools and associated research centres based on data from the research repository. The next step would be the identification of "Category A submitted staff" and the allocation of staff to Units of Assessment, followed by the selection of outputs to be submitted.

#### 18.114 Discussed

- It was highlighted that some staff may not have sufficient publications in the research repository to meet the criteria for "staff with significant responsibility for research" for justifiable reasons (such as maternity leave), and Senate was reassured that this was a preliminary identification stage only, and staff in this situation would be identified at a later stage in the process.
- ii The need to ensure that staff who were not submitted were supported was raised, and the Principal reiterated that the REF was an institutional exercise, and as such it was not possible to include all staff, and support would be available for all staff not included.
