The University Court met today, 8th February 2024.

The Court welcomed Caroline Bysh, PVC Engagement, and Professor Louise Dixon, PVC Education, on joining the University Executive. They heard a brief account from each on their career to date and how they want to take forward these important portfolios.

I confirmed to Court my intention to step down from the role at the end of my current term of office in February 2025. The Vice-Chair of Court will lead the process for the appointment of my successor.
