## EDUCATIONAL AIMS OF PROGRAMME

*Provide a brief introduction, which describes the overview and overall aims of the programme.*

MSc Nursing: Advancing Professional Practice aims to develop the capability of registered nurses to meet the current and future political, clinical, and organisational challenges associated with delivering safe and effective advancing practice in secondary and primary care/Public health environments. The programme's intention is to provide high quality educational experiences to enable registered nurses to acquire the requisite knowledge, skills, and professional attributes associated with advancing professional nursing practice. The programme recognises that advancing nursing practice is a continuous process, predicated on developing and expanding nursing knowledge and skills to underpin high level decision-making and problem solving in challenging and complex healthcare situations. Therefore, this programme has been developed to be professionally relevant and academically challenging in order to meet the contemporary and evolving demands of care delivery. Using a range of dynamic and stimulating intra-professional learning opportunities, the programme aims to build on students existing professional knowledge, skills, and attributes to enable them to extend their capabilities. The programme presented is intended to support registered nurses in advancing their professional practice and career aspirations. Students who successfully complete 90 credits of the core, programme/pathway specific or options modules and accrue 180 credits will be eligible for the Generic Academic Masters award of MSc Nursing: Advancing Professional Practice if they achieve 120 credits a minimum of 60 credits must be core (Advanced Research Methods) or programme specific to allow them to complete and be eligible for PgD Nursing: Advancing Professional Practice.

The following clinical specialism pathways require full employer support and workplace clinical supervision. Therefore, these specialist pathways are only open to supported home students. Those who complete modules within the Advanced Nurse Practitioner pathway, will be eligible for MSc Nursing: Advancing Professional Practice (Advanced Nurse Practitioner, (ANP)). Students who have completed modules within the Advanced Clinical Nurse Specialist pathway, will be eligible for MSc Nursing: Advancing Professional Practice (Advanced Clinical Nurse Specialist (ACNS)). Students who have completed the GCU PgD Advanced Practice in District Nursing with Specialist Practitioner Qualification programme and then join MSc NAPP can complete a dissertation focussed on a district nursing topic to 'top up' (handing back their academic award - PgD) to MSc Nursing: Advancing Professional Practice (District Nursing) (DN). Students who complete 120 credits of the ANP pathway will be eligible to exit with PgD Nursing: Advancing Professional Practice (Advanced Nurse Practitioner). Students who complete 120 credits of the ACNS pathway will be eligible to exit with PgD Nursing: Advancing Professional Practice (Advanced Clinical Nurse Specialist). Students who complete 60 credits in the Clinical Nurse Specialist Pathway will be eligible for the PgC Nursing: Advancing Professional Practice (Clinical Nurse Specialist). All students who achieve 60 credits with a minimum of 30 programme specific credits will be eligible for PgC Nursing: Advancing Professional Practice.

**Programme Philosophy:** Nationally and internationally, Governments and other key organisations, have acknowledged that the delivery of contemporary healthcare will continue to evolve, requiring new ways of working and the contribution and involvement of a highly educated workforce. Crucially, this includes registered nurses who will be expected to act as critical thinkers and problem solvers and as clinical leaders / managers / educators, who advance their own and others' professional practice in the context of continually changing care delivery and multi-disciplinary working. Students undertaking this programme will actively engage in innovative learning processes which

develop personal and professional attributes enabling them to lead developments in practice that focus on improving health outcomes across care boundaries and in a range of dynamic situations. Our vision for the MSc Nursing: Advancing Professional Practice programme and its pathways is that our graduates are globally aware; politically astute; and strategically engaged, in order to ensure the continued advancement of professional practice at local, national, and international levels in line with our common good attributes. The educational aims of the MSc Nursing: Advancing Professional Practice programme and its pathways draw on our leading position as one of the largest nursing departments in Scotland, a globally networked World Health Organisation Collaborating Centre for Nursing Education, Research and Practice Development and our renowned expertise in Applied Health Research, as follows:

1. To provide a flexible, accessible, student centred educational experience, making effective use of learning technologies to meet the varied needs of students.
2. To embed our expertise in applied health research, Long Term Conditions, Self – Management, and Public Health and to provide contemporary evidence base for advanced practice into the future.
3. To utilise our experience in Interprofessional Education to provide opportunities for shared learning in an inter-professional context where appropriate.
4. To maximise our international connections and global networks to expose students to the contemporary challenges and complexities within healthcare at local, national, and international levels.
5. Enable nurses to respond to global societal challenges and contribute to healthcare improvement, as part of a workforce capable of meeting the contemporary and future demands associated with values-based quality healthcare delivery.
6. To promote continued personal and professional development in a health career associated with self-directed life-long learning.
7. To enable students to work as Advanced Nurse Practitioners, Advanced Clinical Nurse Specialists, Clinical Nurse Specialists and District Nurses who are increasingly required for a modern multidisciplinary healthcare service in Secondary and Primary care settings.

- A5 Demonstrate a comprehensive knowledge of theories and policy perspectives, which support and engender multi-professional and new ways of working in modern healthcare systems
- A6 Critically analyse and evaluate leadership roles and responsibilities associated with advancing nursing practice.

**B: Practice: Applied knowledge, skills and understanding;**

- B1 Apply professional accountable, autonomous practice, and high-level decision making to underpin advanced nursing practice in the context and/or district nursing practice
- B2 Explore and evaluate strategies and care planning which are responsive to addressing the health needs of individuals, and communities, requiring complex nursing care

## LEARNING AND TEACHING METHODS

The programme provides a variety of learning and teaching methods. Programme and Module specific guidance will provide detail of the learning and teaching methods specific to each module.

Across the programme the learning and teaching methods and approaches may include the following:

- Lectures
- Seminars
- Practical classes
- Simulation experiences
- Groupwork
- Flipped classroom approaches
- Online learning

The above approaches may be delivered either in person, blended or wholly online as appropriate and determined at module level by the Module Leader.

In addition - Core and elective modules will encourage the development of key transferable skills, achievement of workplace clinical competencies (where appropriate) and enable students to critically reflect, appraise and evaluate their learning and performance. Seminars, student led group discussions, (on-line and/or face-to-face), presentations, problem-based scenarios (on-line and/or face-to-face), simulations, provide the forum for theoretical and clinical creative and social constructive dialogue and interactions, which explore the complex reality and challenges associated with contemporary global nursing, advanced practice, and advanced district nursing practice, Public Health concepts. Formative or summative assessments such as poster presentations, writing a paper for publication, delivering a masterclass in their area of clinical expertise to peers, use of social media to connect with experts, allows exposure to public speaking, peer and expert feedback and feedforward to increase confidence, improve communication, and the use of multiple digital modalities. Students undertaking the MSc Nursing: Advancing Professional Practice programme and its pathways are encouraged and enabled to demonstrate initiative, creativity, curiosity, challenge current thinking, be reflective, and promote active self-directed autonomous independent learning. These strategies enable students to achieve the [GCU Common Good Attributes](#); to ensure they can influence global and local healthcare at a strategic level and locally in the communities they serve.

## ASSESSMENT METHODS

The programme provides a variety of formative and summative assessment methods. Programme and Module specific guidance will provide detail of the assessment methods specific to each module.

Across the programme the assessment methods may include the following:

- Written coursework (essays, reports, case studies, dissertation, literature review)
- Oral coursework (presentations, structured conversations)
- Practical Assessment (Placement, VIVA, Laboratory work)
- Workplace supervision
- Workplace assessments
- Group work
- Blogs and Wikis
- Portfolio Presentation
- Formal Examinations and Class Tests

The above assessments may be delivered either in person and/or online as appropriate and determined at module level by the Module Leader.

The clinical pathways include a range of insitu and workplace assessments in addition to written coursework – For example, Clinical workplace supervision and achievement of competencies or clinical area examinations, (Objective Structured Clinical Examinations (OSCE), viva, case-based discussions, miniCex, Demonstrations of Practice (DoPs), Clinical logs or portfolio of workplace evidence, which allow authentic real-world assessments by clinical experts.

## ENTRY REQUIREMENTS

### Professional Requirements

Applicants to the MSc Nursing: Advancing Professional Practice programme must provide original copies of documentary evidence to confirm current registrations as registered nurse. Accesses to some elective modules are however, also governed by professional and/or employer requirements and therefore necessitates mandatory minimums regarding post registration experience. Modules within the clinical pathway require employer support, access to Practice Assessor and Practice Supervisor/workplace supervision. All clinical modules have strict criteria for entry to ensure access to workplace clinical supervision and assessment is in place. Therefore, these modules are not open to Full time International students. Clinical pathways should be discussed with the Programme Leader before selection.

### Academic Requirements

Applicants will normally be expected to have an honours degree. However, honours awards, for initial nurse registration, is not universally evident in Scotland and consequently a number of applicants may hold unclassified degrees. Those applicants who hold an unclassified degree will require to complete Honours level equivalency which involves submitting an enhanced CV and supporting statement that articulates their learning and development since completing their undergraduate degree. Applicants will be expected to demonstrate recent study prior to the commencement of the programme, in order to support the skills required for masters level learning.

Applicants who reveal a disability will be invited to meet with the Disability Advisor to ensure that specific needs may be assessed. The university's Code of Practice: Students with Disabilities will

apply to entrants to the programme. An audit trail of all documentation relating to the admission process will be held within each student's record. Academic staff with responsibility for admissions have undertaken equality and diversity training to comply with the University's Equality and Diversity Policy.

### **Entry Requirements - International Students**

The MSc Nursing: Advancing Professional Practice programme is suitable for international students, who are post-qualified registered nurses and can provide original copies of documentary evidence to confirm current registrations as registered nurse or equivalent in their home country under the requirements of United Kingdom Border Agency (UKBA) Tier 4 visa arrangements. Applications from International students must evidence and meet the specified entry criteria. International students wishing to study on campus in order to access this programme are required to adhere to the University's policy concerning

International applicants to the programme must provide either: a) evidence of nurse registration, license or certification, or: (b) eligibility to register, by the regulating body in their own country. All applications to the programme citing option b) will be subject to specific evaluation and approval by the Programme Leader.

International students may have additional flexibility within this programme to select study options, which will provide the opportunity to observe practice within NHS settings, subject to local agreement. The programme team work in close partnership with NHS service providers to collaborate in the arrangement of observational visits of applicants. NHS organisations that offer observation opportunities for students may ask for verification of occupational health status.

In line with University requirements, an applicant whose first language is not English or who has not been educated wholly or mainly in the medium of English, will be expected, before commencing the programme, to demonstrate an appropriate level of competency in the English language. The University provides guidance on the minimum International English Language Test (IELTS) of 6.5 for entry to non- professionally regulated programmes with no less than 6.0 in any component.

### **Flexible Entry: Credit Transfer/ Recognition of Prior Learning**

Applicants who are UK NMC registrants are required to adhere to professional requirements regarding Fitness to Practice. ## **PROGRAMME STRUCTURES AND REQUIREMENTS, LEVELS, MODULES, CREDITS AND AWARDS**

The MSc Nursing: Advancing Professional Practice complies with the GCU exit requirements for a Masters programme. This modular programme reflects the Scottish Credit and Qualification Framework (SCQF) and follows the standard Glasgow Caledonian University structure for Postgraduate programmes, which normally comprise 180 credits, of which a minimum of 150 require to be as SCQF level 11. The programme will be offered on a full time – normally 1 year or a part time basis – normally 2-3 years, up to 4 years.

The credit structure for this programme will accord with accumulating 180 Masters level credits by undertaking a combination of mandatory core modules (equaling 90 level 11 credits) and programme/pathway specific modules (equaling 90 level 11 credits). Core modules within this framework involve the study of Research Methods i.e. **‘Advanced Research Methods’ 30 credits and a Masters Research Dissertation 60 credits. Please note the Advanced Research Methods module must be passed before commencing dissertation.**

The programme/pathway specific modules selected by students require relevance for the bracketed pathway/named exit award and selected from the modules hosted by the programme. To be eligible for the exit award MSc/PgD Nursing: Advancing Professional Practice (Advanced Nurse Practitioner/Advanced Clinical Nurse Specialist) the student must achieve all of the modules in that pathway. To be eligible for MSc award – District Nursing or Advanced Nurse Practitioner/Advanced Clinical Nurse Specialist, a dissertation in these areas must be complete in addition to the PgD pathway. Due to regulatory body criteria and no clinical placements for international students, these pathways and exit awards are not available for international students.

International or home students who undertake a flexible pathway will be eligible the generic awards – MSc, PgD or PgC Nursing: Advancing Professional Practice – with the majority achieving MSc. A discussion with the programme leader at admission stage allows tailoring of the programme to individual student’s career and clinical ambitions. Students will also have the option, where appropriate, to select modules available within other Masters level programmes hosted by Masters programmes which map to the learning outcomes of the programme. This credit structure has been adopted to promote a flexible and responsive programme within the MSc Nursing: Advancing Professional Practice.

### **Other Exit Awards**

Students who wish to exit (graduate) the programme at an earlier juncture, or who are unable to meet the academic requirements of the MSc Nursing: Advancing Professional Practice may elect to exit with PgD Nursing: Advancing Professional Practice (120 credits) or PgC Nursing: Advancing Professional Practice (60 credits). To maintain the integrity of the named awards, students who wish to exit with PgD Nursing: Advancing Professional Practice must select and successfully complete a minimum of 60 credits from modules, which are programme specific to this programme and the core Advanced Research Methods module. Students who wish to exit with PgC Nursing: Advancing Professional



Practice must select and successfully complete a minimum of 60 credits from modules, which are core or programme specific to this programme.

### **Exhausting all attempts at a module on the programme (2 attempts)**

Where students cannot achieve the specialist named awards at PgD level (exhaust all attempts at a module) but have attain 60 credits with a minimum 15 credits in the specialist area they may be eligible for the PgC NAPP (CNS) award. Where students are within maximum 30 credits of a named award but have exhausted all attempts at a module within that specialist pathway they may be eligible to be offered two 15 credit or 1 30 credit module to attain the next available NAPP award, stopping the programme and graduating at that award (no specialism) – in line with the current assessment regulations. The same rule will be applied where students are on non – specialist pathways. Where students have exhausted all attempts and have not already attained an award or have another attempt at a module which will allow them to attain the next available exit award they may be offered the chance to retake that module(s) to achieve the next award, exiting at that award in line with the current assessment regulations. Students may also be offered the option to continue on a Generic school award.

Below is a worked example of how students might accumulate credit for MSc Nursing: Advancing Professional Practice (Advanced Nurse Practitioner, ACNS, full time international). An example is also shown which would enable the student to be eligible for the award of MSc Nursing: Advancing Professional Practice.

**Trimester A** - Advanced Clinical Assessment and Decision Making in Acute and Primary Care 15 Credits

**Trimester A** - Applied Pathophysiology for Advancing Professional Practice 15 Credits

**Trimester B/C** - Recognition and Management of the Acutely Unwell Adult (Secondary Care) 30 credits or Work Based Advanced Skills and Innovative Practices (Primary Care contract) 30 Credits

**or** Applied Pathophysiology for Advancing Professional Practice (We prefer you to complete this module before prescribing) 15 credits

**or** Prescribing for Healthcare Practitioners 30 credits (NMC approved separate application)

## **Year 2**

**Trimester A** - Advanced Research Methods (Core) 30 Credits

**Trimester B** - Prescribing for Healthcare Practitioners (additional entry criteria) 30 Credits or whatever modules you still have to complete in the pathway –separate NMC applications must also be completed.

30 credit specialist module – Due to the range of specialism in nursing this pathway require bespoke pathway to be created therefore discussion with clinical teams and students will arrange before commencement – all modules in pathways will be available within the current programme specific or option modules with specialist modules via existing specialist modules or work-based learning.

Details:

**1. Minimum Thresholds: Clinical Modules (TPG Assessment Regs: Section 13.1)**

a. Candidates must obtain a mark of **50% or greater** in each element of coursework and examination for all clinical modules.

In the case of **Objective Structured Clinical Examinations (OSCEs)** candidates must obtain a mark of **70%\* or greater** due to the clinical nature of modules, requiring a higher pass mark.

\* In the case of **Prescribing modules**, the pass mark will be **80% for Exam 1** (normalised to 50%) and **100% for Exam 2** (recorded as pass/fail), as required by the Nursing and Midwifery Council and Health and Care Professions Council.

**Rationale:**

To ensure a level of patient safety to carry out the clinical skills and knowledge required for the clinical roles that the students are being prepared for. Modules which have both clinical and theoretical components require assessment through several modalities to ensure patient safety; this is in line with other clinical modules within the School and other UK HEI clinical advanced practice programmes. This also meets the NHS Scotland triangle of capability: academic preparation; clinical supervision; clinical competence.

**2. Compensation (TPG Assessment Regs: Section 13.2)**

Compensation will not be permitted for students on the Advanced Nurse Practitioner, Advanced Clinical Nurse Specialist, Clinical Nurse Specialist award: students must pass all modules to be eligible for the above-noted awards.

**Rationale:**

Assessment strategies include summative assessment of the student standard of practice and, in light of professional and statutory requirements, it is deemed inappropriate that compensation be allowable for the CNS/ACNS/ANP awards.
