#### What, if any, barriers had to be overcome when developing the initial idea of the project?

- Financial barriers included competing with larger and better-known third sector organisations with an infrastructure that was geared to secure funding. For example, HSGNNL do not have specialist staff, such as an HR finance manager.
- Other barriers involved stigma: some service users may have had to overcome personal barriers which prevented them from reaching out and accessing services.
- Home start had to take proactive steps to ensure it was visible and accessible to
  potential clients. For example, Home Start North Glasgow and North Lanarkshire has
  progressed through the LGBTQI charter to ensure that it is inclusive towards
  marginalised family groups.
- The COVID-19 pandemic and the cost-of-living crisis made it harder to operate Home Starts core model (recruiting and training volunteers).

The support of eight local (community-based) Trustees from different walks of life and with valuable skill sets.
